ASSUMPTION OF RISK AGREEMENT AND INDEMNIFYING RELEASE TO EVERGREEN

In consideration of being allowed to participate in any way in EverGreen Adventure Society's Adventure Day Camps program, and related events and activities, or serve as staff or volunteer for the same, I, and/or the minor participant, and/or person for which I am the legal guardian, the undersigned:

1 Understand that although EverGreen Adventure Society has taken precautions to provide proper organization, supervision, instruction, and equipment for each course. It is impossible for EverGreen Adventure Society to guarantee absolute safety. Also, understand that I share the responsibility for safety during all activities, and I assume that responsibility. I will make my instructors aware to the best of my ability of any questions or concerns regarding my understanding of safety standards, guidelines, procedures and my ability to participate at any point during any activity.

2 Understand that risks during outdoor programs include but are not limited to loss or damage to personal property, injury, permanent disability, fatality, exposure to inclement weather, slipping, falling, insect or animal bites, being struck by falling objects, immersion in cold water, hypothermia (cold exposure), hyperthermia (heat exposure), and severe social or economic losses that may result from such incident. I also understand that such accidents or illnesses may occur in remote areas without easy access to medical facilities or while traveling to and from the activity site. Further, there may be risks not known to me or not reasonably foreseeable at this time.

3 Agree that prior to participation, I will inspect, to the best of my ability, the facilities and equipment to be used. If I believe anything is unsafe, I will immediately advise EverGreen Adventure Society staff present of such condition and refuse to participate.

4 Understand that this ASSUMPTION OF RISK AND INDEMNIFYING RELEASE is binding on my heirs, executors, my administrators, personal representatives, assigns and myself.

5 Agree that I will refrain from the consumption of alcohol and illegal drugs while participating in society programs and activities.

6 Do hereby release EverGreen Adventure Society, its directors, officers, employees, independent contractors and agents from all liability, and do hereby waive as against the company, its directors, officers, employees, independent contractors and agents all claims, courses of action of any kind whatsoever, in respect to all personal injuries or property losses or any other losses or damages of any kind, including but not limited to consequential damages which I may suffer arising out of action of or connected with my preparation for, or participation in, river kayaking, canoeing, survival skills training, hiking, camping and the activities or programs not with standing that such injuries or losses may have been caused solely or partly by the negligence of EverGreen Adventure Society or any of its directors, officers, employees, independent contractors and agents.
